






S.10 of APCO

- (1) Where ... an authorized officer is satisfied that the emission of air pollutants from a polluting process is causing or contributing to air pollution which exists or which is imminent, the Authority ... may give an <u>air pollution abatement notice</u> ... to the owner of the premises or to the person carrying out the activity requiring him-
 - (a) to cease the emission of air pollutants ...;
 - (b) to reduce the emission of air pollutants ...;
 - (c) to take other steps to abate the emission of air pollutants from the premises or polluting process.

S.10 of APCO

- (2) In determining whether the emission of air pollutants is causing or contributing to air pollution which exists an authorized officer may take into account ...
 - (h) any of the following effects which, in the opinion of the Authority or the authorized officer, is caused by or contributed to by the emission ...
 - (ii) an objectionable odour ...

Odour Assessment

Is subjective assessment by human nose acceptable?

Ousely J: "it is <u>not irrational</u> for a court to be able <u>to</u> receive and rely on the evidence of an inspector that <u>he smelt a smell and it smelled horrible</u>. He may be untruthful, he may be unreliable, he may be unduly sensitive, but the courts are not unaccustomed to dealing with that sort of issue"

The judgment was adopted in the New World First Bus case Air Pollution Control Appeal No.3 of 2003

Noise Assessment dB – Noise Meters Does 2 noise sources, each of 60 dB(A), result in a total of 120 dB(A) ?? i.e. any additional 3 dB(A) means doubling the noise energy

Noise Nuisance

Neighbourhood Noise

(e.g. mahjong noise, TV noise, etc)
-Subjective Assessment

Construction Noise

(e.g. piling noise, breaker noise, etc)Regulated by Permit System

Miscellaneous Noise

(e.g. pub music, cooling tower noise, etc)-Subjective Assessment & NoiseMeasurement

Noise v Quietness

Mr Justice Bokhary PJ:

"Objection can be taken on constitutional grounds to any law, regulation or administrative action that creates a state of uncertainty in which persons are inhibited from enjoying their fundamental rights and freedoms in full measure. But playing loud music is not a fundamental right or freedom. And the law does not accord it precedence over the peace and quiet that people can reasonably expect to enjoy."

Noise Assessment Inaudibility

In the Court of Final Appeal case *Noise Control Authority & Another v Step In Limited (FACV No. 11 of 2004*), it was held that the best instrument to measure inaudibility is again the human ear.

Noise Assessment Inaudibility

Sir Gerard Brennan NPJ:

"... although there is some variation in human auditory capacity, the paper written by Professor Craik ... shows that the subjective assessment of audibility is much more uniform and practical than assessment with a sound level meter ...

Application of the "not audible" requirement does not produce a uniform quantifiable measurement but it does produce an objective standard or limit ... "
